Correlation Between Partisan Identity and Ideology ANES Time Series




Figure A1: Correlation between Party and Ideology. In 1972 the correlation was 0.32. In 2016 the correlation between the two variables was 0.70.

Trump's Effect on Public Opinion

In December of 2016 Politico reported that "in July 2014 just 10 percent of Republicans held a favorable view of [Vladimir] Putin, according to a poll conducted by the Economist and YouGov. By September of 2016, that number rose to 24 percent. And it's even higher today: 37 percent of Republicans view Putin favorably, the poll found in December". Essentially, Republicans became four times more likely to view Vladimir Putin favorably over the course of about two years. The left panel of Figure A2 displays a more detailed picture of the change in opinion among both Republicans and Democrats over this period of time. What explains this dramatic shift in opinion among Republican respondents? Over this period little had changed in formal relations between Russia and the United States. Russia's invasion of Crimea in Ukraine took place shortly before the first poll (in February of 2014) and the U.S. response had largely involved merely disputing the legitimacy of the annexation through diplomatic means. There were no other major Russia-related events to change opinion in this period, and the latter poll in 2016 was done long before the true scope of accusations about Russian meddling in American elections became widely known (in September of 2016 the story had barely been reported anywhere). This period, however, broadly coincides with the rise of Donald J. Trump as a political figure, his successful nomination as the Republican candidate for President, and eventual election as the President of the United States of America. Thus, the question to ask is to what extent Trump, his position within the Republican Party, and his relationship to the president of Russia altered Republican answers to public opinion questions. We suggest, and will show through a novel survey experiment, that these types of changes in responses of Republicans are rooted in partisan loyalty rather than thoughtful changes in attitude about Russia or Vladimir Putin.

Evaluations of Putin are far from the only area where Republicans have recently made a dramatic shift. Historically, Republicans have been the political party more likely to favor a conservative approach to trade policy—often favoring the expansion of free trade agreements between the United States and other countries. However, since Donald Trump entered the 2016 presidential campaign, Republican support for free trade has declined, now hovering around only 30% support (see the right-panel of Figure A2. Remarkably, in less than two years, support for a bedrock principle of conservatism fell by nearly 50% among members of the Republican party. Moreover, opinions of Putin and free trade are not isolated issues. In fact, similar stories could be told about Republican attitudes on immigration policy, Wikileaks, and other matters. And, while we use the rise of Donald Trump to study this trend among Republican voters, we believe that given a different scenario that similar




Figure A2: Support for free trade agreements comes from Pew Research Center surveys and favorability of Putin comes from YouGov/Economist surveys.

stories could be told about Democratic attitudes as well, though our focus here will remain on Republicans.

Documenting Trump's Many Positions

As noted in the text, Donald J. Trump takes a wide variety of issue positions. In fact, NBC News felt compelled to write an article (updated throughout the campaign) that was, by late November, titled, "The 141 Stances Donald Trump Took During His White House Bid." Trump's views are described in this piece as "constantly-evolving" and as "the most contradictory and confusing platform in recent history." The article occasionally summarizes Trump's "current position" (although not in all cases) and it makes clear that a semi-attentive voter could have gleaned any number of perceptiosn from Trump's statements during the campaign.

Below are a summary of positions drawn from that piece (as well as a few other pieces cited below) that document Trump's range of positions on the topics we addressed in our survey. Quotations without links are drawn from the linked NBC News piece.

- Minimum Wage: During the primaries Trump "repeatedly argued that raising the minimum wage would move jobs to countries like China" and clearly argued against raising it. However, he also said in an interview with ABC that he would look at raising the minimum wage.
- Taxes: The article quotes Trump as saying that he wanted to cut taxes for the wealthy (in a September plan) but also (only a few days earlier) saying that "I would let people making hundreds of millions of dollars a year pay some tax, because right now they are paying very little tax and I think its outrageous." In the NBC article Trump is identified with seven different tax positions of varying tone and substance.
- Abortion: The main text discusses Trump's positions on abortion, ranging from his pre-campaign position of being pro-choice to changing his position to letting states decide and possibly punishing women who have abortions, to overturning Roe v. Wade to not punishing women who have abortions.
- Immigration: Trump obviously began his campaign by urging the government to build a wall, but in July of 2017 he told CNN that he wanted to bring the good ones back legally. NBC News identified 19 different, often contradictory, positions taken by Trump on immigration.
- Guns in Schools: In NBC News's compilation one of the headings for his gun positions is "No guns in classrooms, except maybe some guns in classrooms." In a May 25 interview with Yahoo, he is quoted as saying "I don't want to have guns in classrooms, although in some cases, teachers should have guns in classrooms, frankly."

- Iran: Trump both said he would keep the deal with Iran and then later that he would renegotiate it. After NBC stopped updating this running tally of positions, Trump was widely reported as leaving the deal in place for now because Iran was complying.
- Health Care: In the February 25 primary debate, Marco Rubio mocked Trump for having "so many different plans" for health care. NBC identified five different positions on health care ranging between covering everyone, repealing Obamacare but keeping the mandate, to not covering everyone and repealing Obamacare.
- Background Checks on Guns: Trump argued often that more guns would save lives, but also argued that he did not mean people like those in the horrific Orlando club shooting should be able to easily get guns.
- Climate Change: Trump argued he did not believe in climate change and that it was threatening his golf courses.
- Planned Parenthood Funding: Trump actually began the campaign by "waffling" (according to CNN) on planned parenthood funding. By February 2016 he had shifted positions to make it clear that he favored defunding planned parenthood, but as of the writing of this article he has done little on that front.

As a final point about the confusing nature of Donald Trump we note that several commentators from the left perceived Trump as being preferable to the other GOP candidates because of his moderation, at least they saw him this way during the campaign. Jonathan Chait said that "a Trump presidency would probably wind up doing less harm to the country than a Marco Rubio or a Cruz presidency. It might even, possibly, do some good." Paul Krugman wrote a pair of columns arguing that both Rubio and Cruz were worse than Trump. And Matthew Yglesias wrote a column in February arguing that Donald Trump was "running on a much less extreme agenda than his "establishment" rival Marco Rubio, who's offering a platform of economic ruin, multiple wars, and an attack on civil liberties that's nearly as vicious as anything Trump has proposed—even while wrapping it in an edgy, anxious, overreaction-prone approach to politics that heavily features big risky bets and huge, unpredictable changes in direction." These sentiments probably seem outlandish today (to his credit, Matthew Ygelsias later updated his article by saying "I realized I was wrong about this") but they underscore the way in which Donald Trump's many positions confuse even veteran political observers.

Proportion in Favor of Liberal Policy in Control Group




Figure A3: Baseline support for each question. We code each question such that a "1" indicates support for the liberal policy option and "0" indicates support for the conservative policy option.

Average Treatment Effect of Policy Cues






Figure A4: Average Treatment Effect

Figure A5: The ATE for each question among Republicans


Probability of Supporting Liberal Policy - Liberal Trump Treatment



Probability of Supporting Liberal Policy - Conservative Trump Treatment




Probability of Supporting Liberal Policy - Congressional GOP Treatment




Each panel shows the individual item effect (positive effects in a liberal direction) for the liberal Trump, conservative Trump and congressional GOP treatment conditions. Though the congressional Republicans generally showed little influence, both the liberal and conservative Trump cues were influential. The immigration question in the conservative treatment is removed because of a technical survey error.

Figure A6: The ATE for each question among Democrats


Probability of Supporting Liberal Policy - Liberal Trump Treatment



Probability of Supporting Liberal Policy - Conservative Trump Treatment




Probability of Supporting Liberal Policy - Congressional GOP Treatment



Each panel shows the individual item effect (positive effects in a liberal direction) for the liberal Trump, conservative Trump and congressional GOP treatment conditions. Among Democrats, all three treatments had little effect.

While it is possible that the difference in treatment effects across issues is simply due to random sampling from a distribution centered on the average treatment effect, we also consider the possibility of systematic heterogeneous treatment effects across questions. While it is possible that the treatment varies by issue based on individual-level factors such as issue salience or intensity of preferences. However, we do not have data that can address these potential individual-based differences, and we leave this question to future research. We do, however, explore the possibility that the treatment varies based on the aggregate support for each issue (see Figure A3 for the distribution of support for each issue in the control group). To do so, we regress support for each issue on the treatment variable. We then interact the treatment with a variable measuring the level of aggregate support for the issue among the control group (so as to avoid the effect of the treatment in either direction). The results, shown in Figure A7, indicate that there is an effect in both the liberal and conservative treatments. We find that issues with more support tend to have smaller treatment effects. In other words, issues with strong (weak) baseline support for the liberal position exhibit smaller (larger) treatment effects in the liberal direction. Likewise, issues with strong (weak) baseline support for the conservative position exhibit smaller (larger) treatment effects in the conservative direction. One explanation for this pattern is that we are observing ceiling effects in the treatments where there is little room for opinion to move in a particular direction because the large majority of the population already holds the opinion in question.




Figure A8: Distribution of Political Knowledge




Figure A10: Distribution of Partisan Identification




Figure A12: Among Republicans




Figure A13: Among Democrats

The ATE by Knowledge - Polynomial Interaction Model




Figure A14: We relax the restriction of a linear interaction with the treatment here. The treatment effect is allowed to vary according to a fourth order polynomial.




Figure A15: Among Republicans




Figure A16: Among Democrats

The ATE by Trump Approval - Fully Interacted




Figure A17: We relax the restriction of a linear interaction with the treatment here. The treatment effect is allowed to vary by each category.




Figure A18: Among Republicans




Figure A19: Among Democrats

The ATE by Self-Placed Ideology - Fully Interacted




Figure A20: We relax the restriction of a linear interaction with the treatment here. The treatment effect is allowed to vary by each category.

The ATE by Party Strength - Fully Interacted




Figure A21: We relax the restriction of a linear interaction with the treatment here. The treatment effect is allowed to vary by each category.
