



TESTS ON THE MECHANISM

In Mexico, politicians holding public office that want to run for an elected position need to step out of their posts before campaigns and pre-campaigns start. They ask for a temporary leave commonly known as *licencia*. These rules apply to most local legislators running for reelection in 2018.¹ This period corresponds on average to approximately 3 months before the election. Thus, by the start of the *licencia* period, parties have already selected which legislators are running for reelection. Since legislators running for reelection are absent during this period, we can determine whether it is a party strategy to engage in more particularistic legislation later in the electoral cycle. If the incentive to get reelected is driving our findings, we should find no shift towards particularistic legislation during the *licencia* period, since legislators in office at this time know they are not running for reelection.

Mexico is a federal system and states are subnational political units with independent executives and legislative bodies. The federal system granted states the authority to self-

determine the number legislators that would comprise their legislatures (Art. 115 of the Mexican Constitution). Thus, there is variance across states in the number of legislators elected in SSDs and those elected in closed lists by PR. This variance implies that local-level SSDs are population-balanced within the state but not across different states. For example, while legislators in Estado de Mexico represent over 200,000 constituents, in Campeche each legislator only represents slightly over 25,000 individuals. State-level SSDs differ to the federal-level SSDs, with the former being drawn according to the national population and the latter concerning the population of each state. First we calculated the proportion of each legislature elected in SSDs. Then, we leverage this variance to estimate the marginal effect of the difference-in-difference estimator (tested in Hypothesis 1) at different proportions of the legislature elected in SSDs. We expect that higher percentages of the legislature elected in SSDs lead to larger average marginal effects of the difference-in-differences estimator because a larger proportion of legislators elected in SSDs implies more legislators looking to cultivate their personal vote.




Figure A3: Average marginal effect of the DiD estimator at different percentages of the legislature elected in SSDs




