HOW THE VIGILANTE GROUP OF NIGERIA (VGN) ASSISTED THE MILITARY ON THE WAR AGAINST BOKO HARAM (BH) FROM GOMBI TO MADAGALI AND MARARRABAN PELLA MAIHA MUBI ADAMAWA STATE OF NIGERIA.

The Vigilante Group of Nigeria and the hunters jointly was invited to assist th military to fight the Boko Haram insurgence on the 16th Nov. 2014. By th Adamawa State Government under His Excellency Barr Bala James Ngilari.

The vigilante Group under the Admin officer of Adamawa State Alha Sulaiman Usman Namtari a 62 years old man led about 1500 members of th vigilant group at different times to fight the insurgence from Gombi to Madaga and from Mararraban Pella through Maiha to Mubi and from Gombi to Garkida.

The root were divided into three groups mararraban pella through Maiha to Mul was led by state commander of VGN Adamawa State Adamu

Abdullahi Gulak. The root from Gombi, Hong, Kala'a, Makera, Mararraban Mut Hildi to Uba which was the most dangerous root because of the high numbers the Boko Haram was taken by the JTF 114 Battalion under the command colonel M.K Gara and VGN commander Alhaji Sulaiman Usman Namta Adamawa state Admin officer VGN.

Along the root we suffered heavy resistance from the Boko Haram membe especially at Mararraban Mubi and Hildi kuma Rock where the military assisted I the VGN had fears battle but by the help of Allah the Boko Haram were crush and their heavy weapons like Armored tanks, A A carriers RPGs and oth weapons were destroyed by the military.

Though the vigilante participated in combat battle, the major role of the VGN, was to ensure peace and stability in any recaptured towns or villages along our root of advancing by house to house searching and patrolling round the captured areas we also conduct search on people moving in out of any recaptured area to make sure No dangerous person or weapons is sneaked into any recaptured areas.

After the recapturing of all areas occupied by the Boko Haram, it is the VGN that will be responsible in fishing out all the BH members that might hide themselves or coming into all the recaptured areas and if any BH member is arrested or any weapons found will handed over to the military.
